### Get Rebates for Qualified Natural Gas Appliance Conversion or Replacement

#### PURPOSE

The purpose of the Energy Conservation Program (ECP) is to provide an incentive for homeowners to switch from another energy source to natural gas or replace existing natural gas appliances with new natural gas appliances in residential dwellings in our service territory.

#### ENERGY SAVINGS WITH NATURAL GAS

The following table illustrates the comparative savings when using natural gas for space heating, water heating, cooking and clothes drying instead of other energy sources. The figures below are calculated based on a home having an annual use of 50 million BTU's of energy. A BTU is a common denominator used to compare various energy sources. Results may vary depending on your actual rate, the efficiency of the equipment used and other factors.

<u>Energy Source</u>	<u>Energy Cost</u>	<u>Annual Savings With Natural Gas</u>
Natural Gas	\$550.00	N/A
Electricity	\$1,172.00	\$622.00
Propane	\$1,365.00	\$815.00
Fuel Oil	\$1,000.00	\$450.00

\* Energy calculation based on Electricity at \$0.08 per KWH, Propane at \$2.50 per gallon, Oil at \$2.50 per gallon and Natural Gas at \$1.10 per therm.

#### APPLIANCE REBATE SCHEDULE

Homeowners who switch to natural gas from another energy source by converting qualified appliances or installing new natural gas appliances are eligible for Conversion Rebates. Homeowners who replace natural gas appliances with new natural gas appliances are eligible for Replacement Rebates.

Water Heater	\$400.00	\$100.00
Dryer	\$75.00	\$50.00

#### PROGRAM GUIDELINES

1. YCNGA will provide rebates (see schedule above) to customers when program conditions are met. Rebates will be credited against balances on any current or previous account. Credits will be applied to the customer's account only and not to a subcontractor account.
2. Customers may purchase appliances from YCNGA or another appliance dealer. Appliances purchased from and installed by YCNGA, will have rebate applied against the purchase price. Customers purchasing appliances from another dealer must fill out a Rebate Request, provide a copy of the sales receipt and have installation of the appliance verified by a YCNGA employee. Appliances converted from another energy source to burn natural gas must be converted by a licensed HVAC contractor.
3. YCNGA has the sole right to determine if an appliance qualifies for rebates under the ECP Program. Some appliances such as Hybrid heating systems and gas logs do not qualify. If you have a question about an appliance, please contact Benton Eavenson at 803.323.5354.

#### PROGRAM CONDITIONS (to receive a rebate all conditions must be met)

1. Customer will complete a separate Rebate Request Form for each individual dwelling.
2. If the appliance is not purchased from YCNGA, the Customer must provide a copy of original appliance purchase receipt or receipt from a licensed HVAC contractor if appliance has been converted from another energy source. (Receipt must not be dated more than thirty (30) days from the date that the request form is submitted)
3. Conversion/replacement of appliances must be verified by a YCNGA representative. Customer will provide access to the dwelling for verification of installation. YCNGA must be able to verify installation of appliance within thirty (30) days of receipt of rebate form.
4. YCNGA will provide one rebate per appliance type (i.e. if two (2) water heaters are installed; only one (1) rebate will apply).
