

Get Rebates for Installing Qualified Natural Gas Appliances

PURPOSE

The purpose of the Energy Conservation Program (ECP) for new construction is to provide an incentive for builders to install natural gas appliances in residential dwellings. Rebates will be applied to builder accounts when a qualified natural gas appliance is installed in new residential housing in our service territory.

ENERGY SAVINGS WITH NATURAL GAS

The following table illustrates the comparative savings when using natural gas for space heating, water heating, cooking and clothes drying instead of other energy sources. The figures below are calculated based on a home having an annual use of 50 million BTU's of energy. A BTU is a common denominator used to compare various energy sources. Results may vary depending on your actual rate, the efficiency of the equipment used and other factors.

<u>Energy Source</u>	<u>Energy Cost</u>	<u>Annual Savings With Natural Gas</u>
Natural Gas	\$550.00	N/A
Electricity	\$1,172.00	\$622.00
Propane	\$1,365.00	\$815.00
Fuel Oil	\$1,000.00	\$450.00

* Energy calculation based on Electricity at \$0.08 per KWH, Propane at \$2.50 per gallon, Oil at \$2.50 per gallon and Natural Gas at \$1.10 per therm.

APPLIANCE REBATE SCHEDULE

Builders who install qualified natural gas appliances in new residential dwellings are eligible for rebates under YCNGA's Energy Conservation Program (ECP) as follows:

Water Heater & Furnace*	\$600.00
Dryer	\$75.00
Range	\$50.00

Maximum Rebate per Service Address \$725.00

* To qualify for the Water Heater and Furnace rebate, a gas water heater and a gas furnace or gas pac must be installed. Hybrid heating systems and gas logs do not qualify. If you have a question about an appliance, please contact Benton Eavenson at 803.323.5354.

PROGRAM GUIDELINES

- YCNGA will provide rebates (see schedule below) to builders when program conditions are met. Rebates will be credited against balances on any current or previous account. Credits will be applied to the builder's account only and not to a subcontractor account.
- Builders may purchase appliances from YCNGA or another appliance dealer. Appliances purchased from and installed by YCNGA, will have rebate applied against the purchase price. A Rebate Request will need to be submitted for appliances purchased from another dealer and for appliances purchased from YCNGA and installed by another contractor.
- YCNGA has the sole right to determine if an appliance qualifies for rebates under the ECP Program. Some appliances such as Hybrid heating systems and gas logs do not qualify. If you have a question about an appliance, please contact Benton Eavenson at 803.323.5354.

PROGRAM CONDITIONS (to receive a rebate all conditions must be met)

- Builder will complete a separate Rebate Request Form for each individual dwelling.
- New appliances only (used appliances do not qualify).
- Builder will provide access to the dwelling for verification of installation. YCNGA must be able to verify installation of appliance within thirty (30) days of receipt of rebate form.
- YCNGA will provide one rebate per appliance type (i.e. if two (2) water heaters are installed; only one (1) rebate will apply).
- To qualify for the Water Heater and Furnace rebate, a gas water heater and a gas furnace or gas pac must be installed. Hybrid heating systems and gas logs do not qualify.
